Note:

- Enter valid 10-digit Permanent Account Number (PAN) first.
- Fields marked with * are mandatory.
- Provision to enter tax amount is given in the Bank's site.
- Do not enter double quotes (") in any of the fields.

Proceed Clear Form Home

Make sure you enter fully functional and operative Email and Mobile.

Make sure Assessment year is filled correctly.

CLICK on Proceed once the form is fully filled and your BANK is selected.

This is Used for Assesseees other than Companies

Tax can only be paid through NET BANKING. It CANNOT be paid through Credit or Debit Card. In case of any doubt, please take guidance of your CA to fill this form.

After you click on “Proceed” as mentioned in the previous slide, you will be taken to your Bank’s Net banking portal. Once you authenticate the transaction using your credentials – the bank will complete the payment and send an acknowledgement on your registered email ID.
